Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form.

Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS.

Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.

Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.







That 30-day period begins with the date of first exhibit, regardless of whether the dog earned any points or awards. To continue to compete in AKC events beyond the initial 30-day period the dog must be either individually AKC registered or by the date of the event have been granted an extension to exhibit using the foreign registration. If you guarantee arrival with a credit card and change your mind, please call the motel to release the room for another person to use.

Routes to the Show Site

PLEASE NOTE - ENTRY INTO THE FAIRGROUNDS IS FROM RT. 91 ONLY.

From Ohio Turnpike - Exit 180 and take Rt. 8 South, to Howe Rd., East to Grounds, North on 91 to Entrance.

From West on I-76 - Stay in left lane to Exit left onto Rt. 8 North to Perkins St. Exit North onto Rt. 8 to Howe Rd. Exit East (right) to Fairgrounds, North on 91 to Entrance.

Breeds designated as ramp optional may, at the discretion of the judge, be judged on a ramp through all levels of competition.
